I. II. Update for Mr. LaRosa passing away.

A. Through November 11, 2002 Mr. LaRosa continued his 36 year tribute each Veterans and Memorial Day to honor his Boys. Mr. LaRosa missed the Memorial Day services in 2003 due to ill health but was represented by his wife and children. The Club's Board and Administrative Staff conducted the service on his behalf.

B. Mr. LaRosa passed away at age 90 on October 9, 2003 still holding the title as Chairman of the Board of the McKeesport Boys and Girls Club. The Veteran's Day ceremony on November 11, 2003 was also held in his memory. His family was presented with two plaques dedicated in Mr. LaRosa's memory: One that lists him as a community leader during the World War II years is to be added to the National World War II monument when it is dedicated this May 2004 in Washington D.C. and the other recognized him as member of America's Greatest Generation.
